Online Booking Security

We use a secure system provided by Realex Payments Ireland - www.realex.ie to process your booking. This system allows you to book online with confidence knowing that your credit card details will be safe. Realex are partnered with AIB Bank. We do not have access to your credit card details when you book online. The transaction is processed in real-time by Realex on a secured internet connection.

Information we collect

- We need your e-mail address in order to send you confirmation of online bookings.
- Unless you sign-up for our newsletter we do not use your email address for any other purpose.
- We would use your phone number if we need to contact you urgently (for example if you had made a mistake entering your email address, change of fixture details etc).
- We do not store your credit card information in our database. We do not have access to this information as the transaction is completed via Realex.
- We log domain names and/or IP addresses for our internal site traffic statistics.
